Narrative Report

At about 0250 I was dispatched to the grand hotel at 200 Hill street. Reference a noise disturbance in room 30.

When I arrived on scene. I met the desk clerk. He was on the phone with another guest who was calling to complain about the noise coming from room 30. I asked him to take me to room 30 because a couple of doors going up to room 30 are locked and a key was needed. When I got to room 30, Dispatch advised me that the phone was still on and that dispatch could hear what was going on. At one point while I was en route dispatch advised me that the male was yelling more and cursing more. I could hear through the door a male voice screaming and yelling calling at someone. The male voice was yelling and saying things such as, "You fucking bitch" "You fucking slut" "You are a whore". I knocked on the door and announced police. The male opened the door and was visibly upset. I asked him to step into the hall with me, I could smell an intoxicating beverage coming from his person.

David stated that he was apart of a cult called scientology and that the female and him were in an fight about the cult. David claimed that the female threatened to kill him. The female was identified as Marisa Sigmond D/O/B [REDACTED] and the male was identified as David Edgare Love D/O/E [REDACTED].

Marisa stated that she never said that she was going to kill david. Marisa stated that she was trying to calm David down.

I issued David that he was going to be issued a citation for disorderly conduct and was transported to the police station for finger printing and photographing. After issuing the citation David called a cab and left. Citation number 2001796.

I asked dispatch to make a copy of the 911 recording of the call. It will be put on the Jerome Police Department hard drive.
